ULLAS (Understanding for Lifelong Learning for Allin Society) is a centrally sponsored scheme by the Ministry of Education, Government of India, also known as Nav Bharat Saaksharta Karyakram (New India Literacy Programme), aimed at empowering adults aged 15 and above who have missed formal schooling. The scheme focuses on literacy, numeracy, and life skills, and is implemented through volunteerism.

New India Literacy Programme (NILP) has been approved by the Government of India as a Centrally Sponsored scheme of Education For All (erstwhile termed as Adult Education) of Department of School Education & Literacy for five years from FYs 2022-27. The scheme is completely aligned with the recommendations of NEP 2020 and many its transformative recommendations were made as a part of NILP such as: ICT based applications, online teaching-learning activities through OTLAS app, community involvement and many more technological interventions for ensuring effective and time-bound implementation of NEP 2020. The scheme has five components namely, (i) Critical Life Skills, (ii) Foundational Literacy and Numeracy, (iii) Basic Education, (iv) Vocational Skills Development and (v) Continuing Education, which will be implemented with an aim of achieving 100% literacy in the country. 2. Only Indian Nationals are eligible for applying.
3. Engagement of Consultant(s) will be on full time (contractual) basis and their place of work will be at New Delhi.
