## 1. BACKGROUND

The New Education Policy 2020 aims to facilitate an inclusive, participatory and holistic approach, which takes into consideration field experiences, empirical research, stakeholder feedback, as well as lessons learned from best practices. NEP 2020 emphasize to provide infrastructure support, innovative education centres to bring back dropouts into the mainstream besides tracking of students and their learning levels, facilitating multiple pathways to learning involving both formal and non-formal education modes and association of counselors/well-trained social workers with schools. It indicates is a progressive shift towards a more scientific approach to education. The prescribed structure will help to cater the ability of the child – stages of cognitive development as well as social and physical awareness. If implemented in its true vision, the new structure can bring India at par with the leading countries of the world.

In view of the above EdCIL (India) Limited is also spanning its spectrum in tune with the New Education Policy' agenda by contributing in improving the learning levels of school students through various appropriate interventions both in terms of **physical infrastructure** and **services solutions**.

**A) Physical infrastructure** may involve majorly setting-up of the following one or all Laboratories in one or more schools/Institutions:

- I. STEM (Basics, Tinkering) Lab,
- II. Vocational education workshops as per NCERT based latest curriculum,
- III. Phonetics / Language Lab,
- IV. Humanities Lab,
- V. Fine Arts Lab/ Graffiti/Wall painting;
- VI. Activity based Learning Kits,
- VII. Science Lab (Physics, Chemistry & Biology),
- VIII. Sports & Music equipment package,
- IX. Pre-primary/ECCE Kits/PSE Kits etc.
- X. Other laboratories as deemed suitable (Other than Smart classroom & Tab labs);

**B) Service solutions** may involve the following services:

- I. Capacity building,
- II. Organizing the workshops/seminars,
- III. Quizzes/ competitions,
- IV. Awareness programs,
- V. Other services as deemed suitable;

### (i) **STEM (Basics, Tinkering) Lab,**

STEM (Science, Technology, Engineering, Mathematics) labs are based on the concept of “learning by doing” i.e. experiential learning in order to

learn the several phenomenon and helpful for children to understand the basic concepts as a whole rather than separate subjects (interdisciplinary approach). STEM basics labs are additional educational resource to understand the basic concepts of subjects viz. Science, Technology, Engineering and Mathematics and STEM Tinkering Labs are based on the experiential learning by adopting interdisciplinary approach. These labs also support teachers to make students understand the subjects in a project /practical application-based approach.

**(ii) Vocational education workshops as per school curriculum,**

NEP 2020 emphasised introduction of vocational courses at an early stage so that the right talent can be tapped at the right time. Vocational education creates awareness and prepares students for work in a specific trade or craft, such as engineering, accountancy, nursing, medicine, architecture etc. Vocational education based workshops are the need of the hour in India to supplement formal education and improve the skills of young India as recommended by NEP 2020. The In CBSE curriculum, various “grade specific” trades have been specified along with the trade curriculum.

**(iii) Phonetics / Language Lab,**

Main aim of the Phonetics / Language Lab is to facilitate students to learn the professional communication and correct phonetic accents as per various industry based demand viz. tourism & hospitality, offices, employment abroad, software professionals etc.

**(iv) Humanities Lab,**

The Humanities Lab provides students with the opportunity to engage in hands-on research on compelling social challenges etc.

**(v) Fine Arts Lab/ Graffiti/Wall painting;**

The Fine Arts Lab brings out the hidden talent/ creativity in students on Art History, Paintings, Art Appreciation, Visual Communication, Animation/ Film-making and Aesthetics. Students are exposed to different mediums and techniques for visual expression such as the print media, computer aided design (CAD) and media, films and animation.

**(vi) Activity based Learning Kits,**

Activity-based learning is the process of learning by doing. Activity-based learning kits/ techniques encourages students to actively participate in learning in their own way through practical activities such as problem-solving, creativity, independent analysis etc. rather to simply listen and take classroom notes.

**(vii) Science Lab (Physics, Chemistry & Biology),**

Science Lab (Physics, Chemistry & Biology) will be based on the subject' standard curriculum of CBSE/State board. The Labs may be a composite lab including equipment of 3 subjects in one room or individual lab for each of the 3 subjects.

**(viii) Sports & Music equipment package**

Physical activities can provide many benefits to the growing children. Sports may be proven a best way for students for their Physical as well as mental growth in terms of teamwork, boost self esteem, go sharper in problem-solving skills and many more. Further a platform for exploration of the musical talent can be provided at an early age to those students who are deprived of the availability of musical instruments.

**(ix) Pre-primary/ECCE Kits**

As per NEP 2020, the uncovered age group of 3-6 years is recommended to be brought under school curriculum, which has been recognized globally as the crucial stage for development of mental faculties of a child. Availability and accessibility to variety of materials can support the child's holistic development which includes physical and motor skills, cognitive skills, language and communication skills, socio-emotional development and creativity.

**(x) Other laboratories as deemed suitable;**

Any other laboratory which deemed to be suitable for improving the quality and learning outcome of the education may be also be suggested.

## 2. AIMS & OBJECTIVES

The objective of the EoI is to understand about the various parameters of the equipment of the laboratories viz. type, performance, functionality, efficiency, quality etc. of products and various aspects of services available in the market. This would help EdCIL to draft the subsequent RfP as per its client's requirement.
