

Scope of Requirement

The interested bidders are requested to consider the following requirements for Procurement "1 KVS online UPS with 2 hours backup" to 21 Schools (List attached in annexure C) of Jharkhand State:

1. Technical Specification of above items are as follow:
 - 1 KVA UPS with 2 Hr Backup
 - UPS should be single phase input single phase output
 - Input voltage: 200V-250V, 50 Hz
 - Output Voltage 110-300V, 50 Hz
 - SMF Battery (3 unites of 12 V 42 Ah Batteries) for minimum 350-Watt load along with battery rack and battery inter connecting cable.
 - ISO 9001, 14001 certification, OHSAS 18001
2. The selected agency will provide 3 years onsite comprehensive warranty on the complete product from the date of commissioning.
3. Transportation cost should be borne by selected agency. No amount towards TA/DA and lodging, boarding or incidental to execution of the project shall be paid.
4. School List as per annexure C.
5. Financial Bid as per annexure B.
6. All the amount shall be indicative by the agency in figures as well in words, where there is any difference between price quoted in figure and words, amount quoted in word shall prevail.
7. Validity of bid should be valid for 30 days from the date of opening of bid. No revision/modification in the quoted rates will be allowed during the period of validity of quotation or the extended period.



8. The corporation reserve the right to cancel the contract if the quality of product and service supplied fail below the required specifications and also if the product and service are not made in accordance with the requirement.
9. The successful vendor shall not sub-let or assign this contract or any part thereof without obtaining prior written permission of the corporation otherwise the corporation shall have the right to cancel the contract.
10. The supply, installation and commissioning of product should be completed within 10 days from the date of issue of work order.
11. Performance Security of 10% of the order value in the form of account payee demand draft, fixed deposit receipt from a commercial bank, bank guarantee issued/confirmed from any of the commercial bank in India or online payment should be submitted by successful bidder in 10 days from the issuance of LOA. Validity of performance security should be 90 days from the completion of the project.

12. Payment Terms:


The payments shall be released on receipt of related payments on back to back basis, as mentioned below:

- a) 90% payment shall be released
 - i) On successful installation of equipments at school level. The delivery certificates, installation & commissioning reports should be signed and stamped by the Principal of the schools.
 - ii) Vendor warranty certificates of product.
 - iii) The e-way bill for the delivery of the equipments have to be provided.
- b) 10% payment shall be released
 - i) After successful completion of 3rd year of AMC

13. Any dispute shall be settled as per the terms and conditions this contract subject to the jurisdiction of Delhi Court.

14. In case of non/partial supply, installation and commissioning of the equipment within the stipulated period, penalty @ 1% of the total contract value for every week of delay on the defaulted amount shall be applicable, subject to maximum of 10% of the contract value.

15. The Successful vendor should not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that,



it's delays in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

- a. For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events shall include, but are not limited to, acts of the Consignee either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- b. If a Force Majeure situation arises, the Supplier should promptly notify the Consignee in writing of such conditions and the cause thereof. Unless otherwise directed by the Consignee in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and should seek all reasonable alternative means for performance not prevented by the Force Majeure event.
